



**ORDINANCE NO. 2019 - 13**

**AN ORDINANCE ADDING SECTION 50.06A TO CHAPTER 50 OF THE ORDINANCES OF THE CITY OF CLAREMORE, OKLAHOMA, REGARDING THE POWER COST ADJUSTMENTS FOR ELECTRIC SERVICE**

WHEREAS, the City of Claremore, pursuant to the powers delegated to it by the Oklahoma Constitution, Oklahoma Statutes, and as a Charter City, has the authority to add section 50.06A to Chapter 50 of the City Ordinances all regarding the power cost adjustments for electrical service; and

THEREFORE, BE IT ORDAINED by the Council of the City of Claremore, Oklahoma, that:

**Section 1. Amendment.** That City of Claremore Code, Title V, Chapter 50 shall be amended by adding Section 50.06A as follows:

**§ 50.06A Modification of Power Cost Adjustment by City Manager**

Notwithstanding any provisions of Sections 50.05 and 50.06 of Chapter 50 of the City Ordinance, the City Manager shall have the authority to change the Power Cost Adjustment charge (PCA) applied to accounts by creating a memo which sets out why such a change would be in the best interests of the City. The City Manager shall have the authority to change the PCA charge to any reasonable amount, whether negative or positive, that will be applied to the account. If the City Manager does change the PCA amount applied to accounts under this section, he/she shall submit the matter to the City Council for approval prior to the effective date of the change. If the City Council does not approve the change by the City Manager, it shall not go into effect.

**Section 2:** The City Clerk is hereby ordered and directed to cause this Ordinance to be published as required by law.

**Section 3:** Emergency Clause. An emergency is hereby declared to exist where by it is necessary for the preservation of the public health, safety and welfare of the inhabitants of the City of Claremore, Oklahoma, that this Ordinance shall be in full force and effect immediately from and after its passage, approval and adoption.

**PASSED AND APPROVED** by the Mayor and Council of the City of Claremore, Oklahoma, this 23rd day of September, 2019, by vote on Sections Nos. 1 & 2 and then by separate vote on Section No. 3 (the Emergency Clause).

§ 50.06A Modification of Power Cost Adjustment by City Manager

Notwithstanding any provisions of Sections 50.05 and 50.06 of Chapter

50 of the City Ordinance, the City Manager shall have the authority to change the Power Cost Adjustment charge (PCA) applied to accounts by creating a memo which sets out why such a change would be in the best interests of the City. The City Manager shall have the authority to change the PCA charge to any reasonable amount, whether negative or positive, that will be applied to the account. If the City Manager does change the PCA amount applied to accounts under this section, he/she shall submit the matter to the City Council for approval prior to the effective date of the change. If the City Council does not approve the change by the City Manager, it shall not go into effect.

Section 2: The City Clerk is hereby ordered and directed to cause this Ordinance to be published as required by law.

Section 3: Emergency Clause. An emergency is hereby declared to exist where by it is necessary for the preservation of the public health, safety and welfare of the inhabitants of the City of Claremore, Oklahoma, that this Ordinance shall be in full force and effect immediately from and after its passage, approval and adoption.
