ORDINANCE NO. 2019-19

AN ORDINANCE AMENDING ORDINANCE NO. 2007-11 AS AMENDED BY NO. 2013-21 OF THE CITY OF CLAREMORE, PROVIDING FOR FUNDS FOR SPECIAL PURPOSES OF THE MUNICIPAL GOVERNMENT OF THE CITY OF CLAREMORE, OKLAHOMA; LEVYING A TAX ON THE GROSS RECEIPTS OR PROCEEDS ON CERTAIN SALES AS HEREIN DEFINED; DEFINING TERMS; PRESCRIBING PROCEDURES, REMEDIES, LIEN AND FIXING PENALTIES; FIXING EFFECTIVE DATE; MAKING PROVISIONS SEVERABLE.

THE CITY OF CLAREMORE HEREBY ORDAINS:

SECTION 1. AMENDMENT OF SECTION 8A OF ORDINANCE NO. 2007-11 AS AMENDED BY NO. 2013-21 Section 8A of Ordinance No. 2007-11 as amended by No. 2013-21, adopted by the City Council on July 02, 2007 and November 04, 2013, and approved by the registered, qualified electors of the City of Claremore, Oklahoma, on September 11, 2007 & February 11, 2014, is hereby amended as follows (all deletions are struck through and insertions underlined and italicized):

“SECTION 8A. TERM OF TAX. The tax herein levied shall be and remain in effect for a period of ~~six~~ ten years from July 1, ~~2014~~2020, subject to approval of a majority of the registered voters of the City of Claremore, Oklahoma, voting on same in the manner prescribed by law.”

SECTION 2. EFFECTIVE DATE. This Ordinance shall become and be effective on and after July 1, 2020, subject to approval of a majority of the registered voters of the City of Claremore, Oklahoma, voting on same in the manner prescribed by OKLA. STAT. tit. 11, Section 16-101 *et seq.*, as amended.

SECTION 3. EFFECT OF AMENDMENT. Except as amended by this Ordinance, Ordinance No. 2007-11 as amended by No. 2013-21 shall continue in full force and effect and Ordinance No. 2007-11 as amended by No. 2013-21 and this Ordinance shall be read, taken and construed as one and the same instrument.
